2022 Dog License Renewals

Issued Dog licenses are now due for renewal starting <u>January 1st</u>. (First time tags can also be purchased at City Hall if they have not already been purchased).

- * Spayed/Neutered-\$15 per dog
- * Non Spayed/Neutered- \$25 per dog

City of Sumas- Business License Renewals

- * <u>Before</u> January 27th: Renew through City
 Hall to avoid paying State fees
- * <u>After</u> January 27th: Must apply through the link below, on the State BLS portal

Sewer Rates

Sewer rates are calculated based on <u>actual</u> water usage. Keep an eye on your monthly water usage to find any potential water leaks. Please call City Hall if you have any questions.

Utility Shut-off's

As we get back into a routine at City Hall, we will be resuming utility shut-off's, starting in February. With the mail being a little behind, it is important to think ahead and make sure payments are mailed out in a timely manner or any payments made through your bank, are processed a little earlier. Even though the money may leave your bank account that day, does not mean the City will receive your payment that day. Keep in mind your bank still mails a check on your behalf to City Hall, which may take up to a week for the office to receive.

3 Ways to Apply for Disaster Aid











The U.S. Small Business Administration (SBA) is responding to the Presidential Disaster Declaration announced earlier this week regarding the November 2021 floods. Low-interest federal disaster loans are now available to businesses and residents.

The first step is to register with FEMA Federal Emergency Management Agency. There are three ways to do this:

Google Play: text ANDROID to 43362 (4FEMA)

(Note: deadlines for applying through the SBA for physical damage is March 7, 2022 and for economic injury is October 5, 2022.)
