## Foreword

### Authority

This document is the Water System Plan (WSP) for the City of Sumas, Washington. Preparation of a WSP is authorized pursuant to WAC 246-290-100, but is only mandatory for certain kinds of water systems. Until recently, Sumas did not fall into any mandatory category, and system planning occurred on an infrequent project-driven basis. However, Sumas now falls into a mandatory category because of the development by Whatcom County of a county-wide Coordinated Water System Plan (CWSP) that encompasses Sumas. WAC 246-290-100(2)(b) requires water systems located within CWSP planning areas to prepare a WSP.

### Engineer's Certification

In accordance with WAC 246-290-040, Public Water Systems, Engineering Requirements, this City of Sumas Water Comprehensive Plan (December 2011 Revision) has been prepared under my direction.
